

- 1.5 The limitations and exclusions in this clause 1 shall not apply death or personal injury arising from negligence, except to the extent permitted der the Unfair Contract Terms Act 1977.
- 1.6 BESA shall have no liability whatsoever or howsoever arising inspect of any claim of which it is not notified in writing prior to the first anniverry of this contract.

2. INDEMNITIES AND INSURANCE

- 2.1 The company undertakes to indemnify UK Trade & Investment (DIT) in accordance with DIT Terms and conditions for Exhibitions and indemnify and keep indemnified BESA against any claim by DIT agret BESA in respect of the matters covered by the said indemnity.
- 2.2 The company further undertakes to indemnify and keep indemnifiæ£SA against all costs, charges, expenses, claims or losses of any nature #sered by BESA as a result of the company's failure to comply with:
 - a) its contract with BESA
 - b) the terms and conditions under DIT
 - c) the exhibition organisers' terms, conditions, rules and religitions.

3 CONTRA ACCOUNTS

BESA reserve the right to deduct from any sums due or which mbecome due to the company under this or any other contract with BESA, any sum which is due or which may become due to BESA from the company under this or anther contract.

4 DAMAGE

No damage may be caused to the display aids/furniture supplicand if so caused companies will be liable for the full cost of repl**e**ment.

5 VARIATION OF COSTS

Charges related to the provision of space and stand construction may be adjusted by BESA in the light of actual costs and any increase shall to be adjusted by the space of the standard standar

6 FAILURE TO PAY

BESA shall not be bound to provide space and/or any standripæompany if BESA has not received payment in full of all monies due.

7 CANCELLATIONS

There is a 50% cancellation charge for cancellations of contract prior to $\bf 30\,March\,2020$ after which date the cancellation charge is 100% of the contract value.

8 CANCELLATION OF THE EVENT

If for any reason the event is cancelled before BESA has comr**t**eid, or becomes committed to make, any expenditure any monies collected will **beha**rised. 13 TERMINATION OF CONTRACT

- b) the company fails to remedy any breach of contract within reasonable period of being requested in writing by BESA so tood
- c) in BESA's reasonable opinion there is insufficient support far the exhibition.
- d) DIT withdraws support for the exhibition.

14 AMENDMENT, SEVERABILITY AND WAIVER

This contract and these terms and conditions or any of them can be varied, suspended or added to without BESA's written consent. If this atract or these terms and conditions or any of them is judged by any competendurt to be invalid or unenforceable, the remaining part or parts shall ninue in full force and effect. Any neglect, for bearance or indulgence on theart of BESA relating to rights under this contract, the terms or conditious any of them shall in no way be deemed a waiver, implied or otherwise, or such rights.

15 FORCE MAJEURE

BESA shall not in any event be held responsible for or liablerffailure to perform its obligationshereunderif such failureresults from circumstances not under BESA's control.

16 NOTICES

Notices will be in writing and will for all purposes be deemed have been fully given and received when actually received and they will be not postage prepaid properly addressed to the parties at their respective dresses first above written in this contract or at such addresses for eith party as may be specified by such party for such purposes above written in this intract or at such addresses for either party as may be specified by such party fauch purpose.
