OxEd and Assessment is a University of Oxford spinout company launched to take the world-leading research of Professor Charles Hulme's research group on early language and reading through to practical application in schools.

Our programme consists of LanguageScreen, an app to assess language ability, the Nuffield Early Language Intervention (NELI), a 20-week oral language intervention, and online training and mentoring.

Schools begins by assessing the language skills of all children. LanguageScreen is a simple 10-minute digital assessment to assess children's speaking and listening skills and identify those requiring intervention. It requires no specialist expertise and has been shown to have similar accuracy as traditional paper tests. Results are instantly available in easy-to-interpret reports.

The intervention then involves a trained teaching assistant providing small-group and individual sessions to 3-6 pupils. These structured sessions provide a vocabulary-rich environment for children. Schools are provided with teacher manuals plus everything needed for the activities, saving preparation time. Full training is provided to ensure practitioners are skilled in delivering the intervention.

At the end of the year, retesting with LanguageScreen not only provides a clear measure of the impact of intervention but also allows teachers to track progress of all children over the year.
