Geoff Gladding led on the creation and delivery of the Government's International Education Strategy, in which Education Technology and supplies play a strong part. Rosemary (Rose) Luckin is a UCL Professor, Founder of EVR Ltd and host of the EdTech podcast. She is renowned for her research in Artificial Intelligence (AI) and education. She was named one of the 20 most influential people in education in the Seldon List 2017 and was winner of the ISTE Impact Award 2023.

Rose is frequently asked to provide expert evidence to policy makers, in both Houses of the UK Parliament, the European Commission and further afield. Rose has published prolifically in peer-reviewed academic journals, books and conferences, and her most recent book, 'Al for Schoolteachers' is an essential and accessible guide to Al for anyone involved in education.

Ann Mroz is the former editor of TES (Times Educational Supplement) and Times Higher Education.
